Education: Locally Haiti supports operations at St. Paul's pre-school, primary, and secondary school in Petit Trou. In 2019-2020, 385 students benefitted from St. Paul's holistic educational services, these including traditional coursework in addition to hands-on experience in agriculture, girls' empowerment, and entrepreneurship. In higher education, Locally Haiti has funded higher education scholarships for over 30 students. In 2020, LH funded two students in agriculture / agronomy and one in teaching. In 2020, LH funded three key components of infrastructure on campus: Transition to a solar micro-grid that powers the campus of St. Paul's School; Completion of first phase of an expansion of the St. Paul's Farm & Agricultural Education Center; Demolition of an unsafe structure on campus.

Agriculture: Locally Haiti supports family farms by providing access to seed, tools, goats, and trainings and consultations from a full-time staff agronomist in Petit Trou. In addition, this agronomist works with students at St. Paul's School, providing formal instruction in the classroom as well as weekly hands-on learning sessions working on the campus farm. The agronomist also visits with families of St. Paul's students and staff, providing resources and consultation that increase outputs and access to nutrition.

Girls' Empowerment: Locally Haiti partners with local leaders and expert Haitian organizations to provide dedicated programming for girls' empowerment in Petit Trou. This includes paying and training local mentors and community activists, funding girls' clubs and activities, and funding practical trainings for girls and young women.

In 2013, the Organization, by board resolution, established the Education for Haiti endowment fund (Education Endowment) with donor restricted contributions. The purpose of the endowment is to support the education of
